

Dear Parents,

It is time to sign up for dance at Aucilla. I am Ms. Mary, Aucilla dance instructor, and I am super excited to meet all the new dance students and welcome back my previous dance students! My company, The Mobile Dance Co., is the dance program offered at ACA. Dance classes will be offered to students from K-4 through 12th grade. As in previous years dance class will be held during P.E. period once a week. Thanks to the cooperation from the teachers and coaches, this has worked out great in the past!

All dance classes will be held on Thursdays. All classes will be a combination of Ballet, Tap, Jazz (as well as hip/hop & contemporary/lyrical for the more advanced classes). The dancers will need to wear leotard, tights, dance skirt/short/or pant. They will need to have black tap shoes & pink ballet slippers with elastic for all dance classes, with hair pulled up away from face and neck. Third grade and up will also need black jazz shoes. We will have a dance recital in May so costume/recital fees will be due November 1st so we may place the costume order in December.

Payment periods are divided into sessions, each session is \$35 and due on the 1st of every month. There is no session fee for May for those who enroll by August 18th. The session break down, class schedule, and fees are listed on the next page.

There are two ways to pay, you may make an online payment on my website www.themobiledanceco.com - click the Aucilla Christian Academy tab at the top of page and find the "Aucilla session 1" pay now button. OR you may send a check to the front office in a envelope labeled "Dance". Please make checks payable to The Mobile Dance Co. and they must be submitted by the 1st of each month.

There are two ways to enroll. You may complete the online registration form on the website, www.themobiledanceco.com under the registration tab OR complete the attached paper enrollment form and return to your child's teacher or main school office.

Payment of session 1 and completion of enrollment slip or online registration form will enroll your child in dance. Enrollment forms and payments can be submitted to Cathy Jackson in the Business Office OR online. I do have a cap on enrollment in each class and some classes fill quickly, so please enroll ASAP to ensure your child's placement.
